- 1.1 To reduce the process time for assessment and deliberation of AAA from 2 years to 1 year or less.
- 1.2 To improve the efficiency in the administration of the judging process
- 1.3 To increase awareness, participation amongst AAA members
- 1.4 To expand the promotion of AAA not only amongst ARCASIA members but also globally

4.0 AAA Process

- 4.1 Offer by Host Country of ACA / FORUM to be the Secretariat of AAA and approval by ARCASIA COUNCIL . This usually coincide with ARCASIA Forum or Conference and nominated 1 year preceding the award
- 4.2 Appointment of Convenor from Host Country
- 4.3 Announcement on the Opening of Nominations by Convenor [through AAA Secretariat]
- 4.4 Submissions of nominations by individu / Institute with a declaration of eligibilty
- 4.5 Announcement on the Closing of Nominations by Convenor [through AAA Secretariat]
- 4.6 Convenor to issue the list of nominations received to all Member Institutes for confirmation.



4.0 AAA Process

....

- 4.7 Nominations Review by Convenor through AAA Secretariat on the compliance of Nominations received
- 4.8 Distribution of Nominations to Jury by Convenor through AAA Secretariat. This will be done via online and cd [or hard copy]
- 4.9 Announcement on all accepted nominations via online [ARCASIA website]. Only images and information pertaining to the nominated projects to be published
- 4.10 Submission of assessments and recommendations by AAA jurors to Convenor
- 4.11 Meeting and deliberation of AAA Jury panel for the FINAL DECISION ON AAA. Date and Venue to coincide with other ARCASIA function.
- 4.12 Announcement of AAA to the winners
- 4.13 AAA Ceremony at ACA / FORUM
- 4.14 Publications and promotions [online and hardcopy]

- 4.1 Cost for website
- 4.2 Cost of travelling for Jury deliberation

6.0 Issues for consideration

- 6.1 Members of Jury Panel must have access to internet to receive the approved nominations, to do assessment , communicate with the Convenor and submit assessments on recommended AAA
- 6.2 Website has to be monitored and maintained for the whole duration of judging
