	1.7	<p><b>Information about Auditing companies</b> - Hon. Treasurer Ar. Junichi Ito</p> <p>OBs are informed that 3 Auditing Companies have been contacted by the Hon. Treas. and that the cost of auditing in Japan is from 3000 to 5000USD, much more expensive than the 300USD fee of Bangladesh Accounting firm.</p> <p>Possible solutions are discussed:</p> <ul style="list-style-type: none"> <li>a) To make the accounting at an old certified accountant acquaintance of Ar. Kunihiro.</li> <li>b) To have the accounting done again in Bangladesh for about 500USD, or to another country where the fee is low. This requires a council proposal for a change of the Bylaws that actually impose that the accounting is done in the country of the President.</li> <li>c) To have the accounting done permanently in Hong Kong where the bank account of ARCASIA is located. Also this requires a change of the Bylaws.</li> </ul> <p>It is decided that Zone C VP Ar. Kwong will inquire about accounting fee from a CPA Accountant in HK where ARCASIA has the account. The same is requested to Advisor Ar. Reyes in Philippines, because it is the country where ARCASIA is registered.</p> <p>Information should be submitted to Hon. 	2.4.2	<p>The President notes that some of the countries named by Ar. Tandanand are possible candidates for membership, while others like Kazakhstan do not actually belong to Asia. The demarcation line for Asian countries was drawn clearly and should be maintained. These other countries can be approached through an MOU.</p> <p>The President thanks VP Zone B and asks him to come up with an implementation plan for the proposed activities, especially for the Social Responsibility Committee.</p> <p>VP Zone B replies that instead of making up something new we should look at what ASEAN and APEC architects already have as guidelines and help our member countries to work within those guidelines. President agrees but stresses the need to identify what must be practically done for the proposed items.</p> <p>Ar. Reyes proposes to make a road map which shows what must be achieved with what timing and how, so we will know for each term (for example in 2 years steps) where ARCASIA will be.</p> <p>The proposal is seconded and VP Zone B will prepare such a road map to submit asap to the OBs for comments and then to the next Council in Danang for approval.</p> <p><b>Workgroup on “Continuity”:</b> Ar. K. Siddiqui, V.P. Zone A, says continuity under his chairmanship is mainly about scholarship and ACAE. Those topics are still being discussed and cannot fully report at the moment. Ar. Siddiqui asks also the President to provide more guidelines on the work he should do on this topic.</p> <p>The President explains that ARCASIA should be committed as much as possible to its members and the people, be relevant and important for the Institute’s members. Continuity does not mean exclusivity. ARCASIA should not be an exclusive club. A lot of committees have been doing a lot but it all depends on the chairman. We should have a system in place that encourage new participation, new membership so that all activities can flow and continue to new members while the old ones pass on to the Fellowship and relax. This is why ARCASIA does not have permanent advisors anymore: to avoid exclusivity and to promote change and innovation.</p> <p>Ar. Siddiqui says that the individual Institutes have the same problem of being perceived as exclusive clubs. So the Institute should have a system inside, a policy that binds them more to ARCASIA.</p>	<p><b>Closed</b></p> <p><b>pending</b> action by: VP Zone B</p>

	<p>President says that a key issue is also funding: highly needed if we want to bring people inside and make activities for them. Ar. Siddiqui agrees and says that is important that ARCASIA has some project to offer to prospective members.</p> <p>The President says that CPD could be the mechanism that binds together the Institute members, and the Institutes and ARCASIA. If ARCASIA has a CPD program as the UIA and the AIA then it will become relevant. With a CPD program a member could attend events all over Asia and gain continued training and experience and points to renew his/her license no matter what Institutes he belongs to.</p> <p>Ar. Reyes notes the importance of international exposure of ARCASIA's activities. We already have established some actions: we have first of all be noted and recognized as important by the members of each Institute and by the students. For example the ARCASIA Heritage book might improve our image and also be used as a text for bar examination.</p> <p>The President thanks for all these inputs and asks to continue to work to develop these ideas into projects and programs.</p> <p><b>2.4.3</b> Workgroup on <b>"Growth and New Membership"</b>: Ar. A. Kwong, V.P. Zone C, affirms the importance of a good PR for ARCASIA and proposes to start with a small project workable during the current OB duty period.</p> <p>Regarding CPD, HK is making mandatory now 40hours every year for membership renewal, more or less like China (80hrs every 2 years). So the first step would be to go back to our Institutes and inform them more of the importance of ARCASIA.</p> <p>The President says that he talked with the person in charge of CPD at UIA and that they recorded in their minutes that they want to work with ARCASIA. He adds that maybe ARCASIA does not need to create any system but be a facilitator for the use of CPD gained in several countries and also ARCASIA can tap into the UIA CPD program so that if one goes to a UIA country he can gain credit.</p> <p>The President asks the VPs to continue in working on this CPD issue.</p>	<p><b>pending</b> action by: VP Zone A</p> <p><b>pending</b> action by: VP Zone C, Zonal VPs</p>

Kwong says that the same is for APEC which is attaching a lot of importance to CPD program, Not all ARCASIA countries are ASEAN members and not all ARCASIA members are APEC architects, so we need to work with both institutions.</p> <p>Ar. Reyes proposes to have a promotion video about ARCASIA and to present it at National Convention of the 17 member Institutes, so we educate every member.</p> <p>Ar. Siddiqui says that IAP made a 15 min. film about ARCASIA for the students to see. He will be presenting the ACA-14 video in Vietnam.</p> <p>OBs reply that the video to be shown at the Council meeting should be max 7 min. and that the video for presenting ARCASIA could be 5 mins.</p> <p>Ar. Kwong asks about the feasibility of making the CPD program a requirement for ARCASIA membership, i.e. Institutes which do not have the CPD program cannot become members.</p> <p>The President replies that ARCASIA is not in a position to dictate but only to encourage. We already have information about which ARCASIA countries have a CPD program.</p> <p>Ar. Tandanand adds that just getting together and sharing ideas is a good PR action. The Tri-nations meeting is a platform that has greatly helped to know where PAM and ASA are going. We could begin to increase the sharing of information on a Zone level. Also when the Office Bearers travel around they already are doing PR, and they increase the ARCASIA international presence.</p> <p>Ar. Pei Ing proposes that members of ARCASIA should share information of their activities so that it does not have to re-invent the same things but can reuse existing knowledge.</p> <p>The President agrees with the idea of sharing and says that the Tri-Nation is an excellent case study that needs further attention.</p> <p><b>Workgroup on “Funding and sponsorship”:</b> since the VPs have not discussed this in detail yet, the President explains again his idea. ARCASIA has about 63,000USD in its bank account, which is very small compared to the budget of the single member Institutes, but it's trying to expand and create activities so it needs an additional source of funding.</p> <p style="text-align: right;"><b>pending</b> action by: Zonal VPs</p>

		<p>Ar. De Zoysa and Tandanand propose to establish a category of “partners or sponsor”, so that each time there is a Forum or a Congress they will be there and get exposure in exchange for funding.</p> <p>Ar. Siddiqui and Reyes note that this approach might generate problems of influence on elections.</p> <p>Ar. Tandanand replies that UIA has corporate sponsors (big cement companies, companies related to architectural products or energy related companies). ARCASIA could just as well be selective of its partners.</p> <p>Ar. Reyes says that corporate funding could be allowed but it should be limited to special projects and not extended to the funding of the whole ARCASIA organization.</p> <p>The President says that with the actual level of money ARCASIA is not able to do much new but just to maintain the status quo, and that he does not want to exhaust ARCASIA coffers.</p> <p>The Office Bearers tell the President that the important is how the money is spent and that as long as the money is spent for the good of ARCASIA the President has the right to do so.</p> <p>The President thanks but notes that the existing fund may be ok for individual, limited projects, while ARCASIA needs a more long-term funding solution for the 10 year growth plan.</p> <p>It is decided that the 3 Zonal Vice Presidents will discuss this issue and come up with some proposals.</p>	
	2.4.5	<p><b>Proposal and program of Social responsibility Committee:</b></p> <p>Ar. Tandanand explains what ASA has done.</p> <p>The thing that ASA did to make the Institute relevant to government organization in the country was to help on the social side.</p> <p>ASA created a model, a mockup showing the general public what it takes to design for people with disabilities. This showed that it did not take much to design for a universal type of user.</p> <p>Another experience was for conservation of historic buildings, through vernacular documentation: students document buildings and this work is published on newspapers and then buildings are recognized as valuable and preserved.</p> <p>Also work on community improvement is very successful because politicians recognize that there is a constituency,</p>	<p><b>pending</b> action by: Zonal VPs</p>

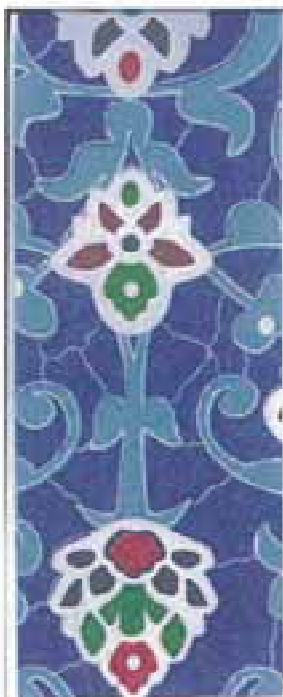
