### INTRODUCTION

The Architects' Regional Council Asia (ARCASIA) is a Council of the presidents of the National Institutes of Architects of twenty-one Asian countries that are members of ARCASIA. Every year, Asian Congress of Architects (ACA) or Forum is hosted by one of the member countries of ARCASIA. The ARCASIA Thesis of the Year Awards will be organized by ARCASIA, commissioned under ACAE (ARCASIA Committee for Architectural Education (ACAE) and coordinated by host institute for Forum or ACA.

### OBJECTIVE

The objective of the ARCASIA Thesis of the Year (TOY ARCASIA) is to provide an arena for the schools of architecture in ARCASIA member countries and their first architecture professional degree (~~B.Arch~~ or ~~M.Arch~~), whichever qualifies as first accredited degree by respective National Boards/Authorities/Councils. Students are to display their potentials and fresh ideas in international platform provided by ARCASIA in order to heighten and elevate architecture education in Asia. TOY ARCASIA is dedicated to fresh ideas in Thesis from the final-year students in first professional degree programs of each country members. It opens a route to the knowledge exchange of architectural education.

### ENTRY ELIGIBILITY

The works are submitted by ARCASIA Member Institutes. Each institute must set up a procedure to select National Winners and submit 3 (three) national winners to TOY ARCASIA Committee for the final judging (by TOY ARCASIA Judging Committee). The work must be a latest/currently completed thesis of the fifth or final-year student in a first professional-degree program (5 years ~~B.Arch~~ or 4+2 years ~~M.Arch~~ accredited and qualified for professional registration of the country). However Thesis of Post Professional or Post Graduate Courses i.e. Master Programs that are taken after ~~B.Arch~~ course (Professional Degree) will not be eligible for the consideration. Students cannot submit their work directly to TOY ARCASIA.

### JUDGING GUIDELINES

All the entries must be the final-year project and the jury will judge those works according to the following criteria: • Concept • Spatial integration The design should respond and be sensitive to its context and also the way users interact with the space. Although the floors are separated, the design should present some form of integration—how it benefits or impacts the building and its users should be in place. This could be pursued by means of the building form and function or any criteria already set here. There should be an integration of access and circulation in the scheme. An overall sense of place needs to be established to give the neighborhood space a unique character, enhance the walking environment, and create satisfaction in individual and whole space integration. • Goal • Form The jury will consider how the project's form reveal the project's goal through its materiality, shape, detailing, etc. The project's form should have a clear stance on its relationship to its surroundings, its users, and the public at large. It is not enough to be beautiful, and the form need not be cutting-edge or trendy, but rather of high quality, and is appropriate and relevant for its users and the message it is supporting. The project should demonstrate design excellence and quality, that it should fit its purpose and that it should be sustainable. There should also be harmony between the proposed interior designs and the building itself. • Functionality of the design Function refers to achieving the goal which is set by the applicant. This is frequently a complex and diversity of requirements that can range from the simple living space to the complicated social interactions. The jury will refer to the project's description to understand which functional criteria was the primary concern. Good functionality means the project works well for the intended use, including for its users, that occupy the project, and the public that encounters it. • Innovation and originality of the design solution This is one of the key components of architectural design to embrace new technologies and countenances shifting social and demographic trends with curiosity. Projects that take a fresh approach, work to improve existing practices, and push the boundaries or perceptions in the field are innovative projects.

### PRIZES

There will be up to three winners to be awarded as:

- 1) **Gold Award** for the work that receives highest merit by majority of the judges, or receives the highest total score from all judges.
- 2) **Silver Award** for the work that receives the second highest merit by all judges, or receives the second highest total score from all judges.
- 3) **Bronze Award** for the work that receives the third highest merit by all judges, or receives the third highest total score from all judges.

### EXHIBITION AND PUBLICATION OF ENTRIES

The organizer is entitled to display or exhibit on any date and in any venue the entries or any part thereof, and publish including the report of the category events together with any selected entries.

#### I. Overview

- 1.1 The ARCASIA Thesis of the Year is a prestigious architectural thesis competition that celebrates the innovative and socially relevant work of architecture students across Asia. Initially conducted by the Association of Siamer Architects (ASA), the competition was later adopted by the Architects Regional Council Asia (ARCASIA), an assembly of 22 member countries. **(TO BE EXPOUNDED FURTHER)**
- 1.2 The competition aims to provide a platform for the brightest minds in architecture to showcase their fresh ideas and potential on an international stage. It focuses on themes that address critical social issues, display innovation and originality, and consider global needs and challenges.
- 1.3 Each year, architectural students from ARCASIA member countries are invited to submit their work. The theses are first evaluated at the national level by their respective institutes. The top entries from each country are then submitted to the ARCASIA Committee on Architecture Education for final judging.
- 1.4 The competition culminates in an awards ceremony held during the ARCASIA Congress or ARCASIA Forum, where the winners are announced. In essence, the ARCASIA Thesis of the Year competition is not just a contest, but a celebration of the talent, creativity, and commitment of the next generation of architects in Asia.
- 1.5 The ARCASIA Thesis of the Year (TOY ARCASIA) aims to establish a competitive platform for architecture schools from ARCASIA member countries. The following are its specific objectives:
  - 1.5.1 **To Recognize Excellence:** The primary objective of the ARCASIA Thesis of the Year is to recognize and reward excellence in architectural thesis work produced by undergraduate students from ARCASIA member countries. The competition aims to highlight exceptional talent and innovative ideas within the field of architecture.
  - 1.5.2 **To Encourage Innovation and Originality:** The competition seeks to

2.2 The thesis should be recent, **not older than two school years from the date of the competition award.** For example, if the competition will be awarded in September 2024, the thesis should have been produced between September 2022 and September 2024.

2.3 The thesis should be a product of students pursuing their first professional degree in architecture, be it B. Arch, B.S. Arch., or M. Arch, depending on which is recognized as the first accredited degree by their respective National Boards, Authorities, or Councils. Thesis of Post Professional or Post Graduate Colleges' (2) Master Programs that are taken after B. Arch course (Professional Degree) is not be eligible for joining.

2.4 Individual or group thesis is allowed.

2.5 The thesis entry must have any or all of the following characteristics:

**2.5.1. Thesis with High Social Relevance:** The thesis should address a pertinent social issue or need. For example, focusing on urban architecture solutions for overcrowding or slum redevelopment can demonstrate a high level of social relevance. The thesis should aim to provide better living conditions, sanitation, and well-being for the community it serves.
