Please take notice that the Court, Second Division, issued a Resolution dated October 30, 2024 which reads as follows:

"G.R. No. 200015 (Department of Public Works and Highways vs. Philippine Institute of Civil Engineers, Inc. and Leo Cleto Gamolo); and G.R. No. 205846 (United Architects of the Philippines vs. Philippine Institute of Civil Engineers, Inc. and Leo Cleto Gamolo). - Acting on the respondents Philippine Institute of Civil Engineers, Inc. and Leo Cleto Gamolo's (1) motion for reconsideration of the Decision dated March 15, 2023; and (2) motion for referral of the case to the Supreme Court *En Banc* dated December 11, 2023, praying that the aforesaid motion for reconsideration be referred to the Honorable Court *En Banc* for resolution, the Court resolves to:

1. DENY the motion for reconsideration with FINALITY, the basic issues raised therein having been duly considered and passed upon by the Court in the aforesaid decision; and
2. DENY the motion for referral of the case to the Court *En Banc* pursuant to the SC Circular 2-89 dated February 7, 1989 which provides that the Court *En Banc* is not an appellate court to which decisions/resolutions of a Division may be appealed.

No further pleadings or motions shall be entertained in this case. Let entry of final judgment be issued immediately. *Kho, Jr., J. on leave.*"

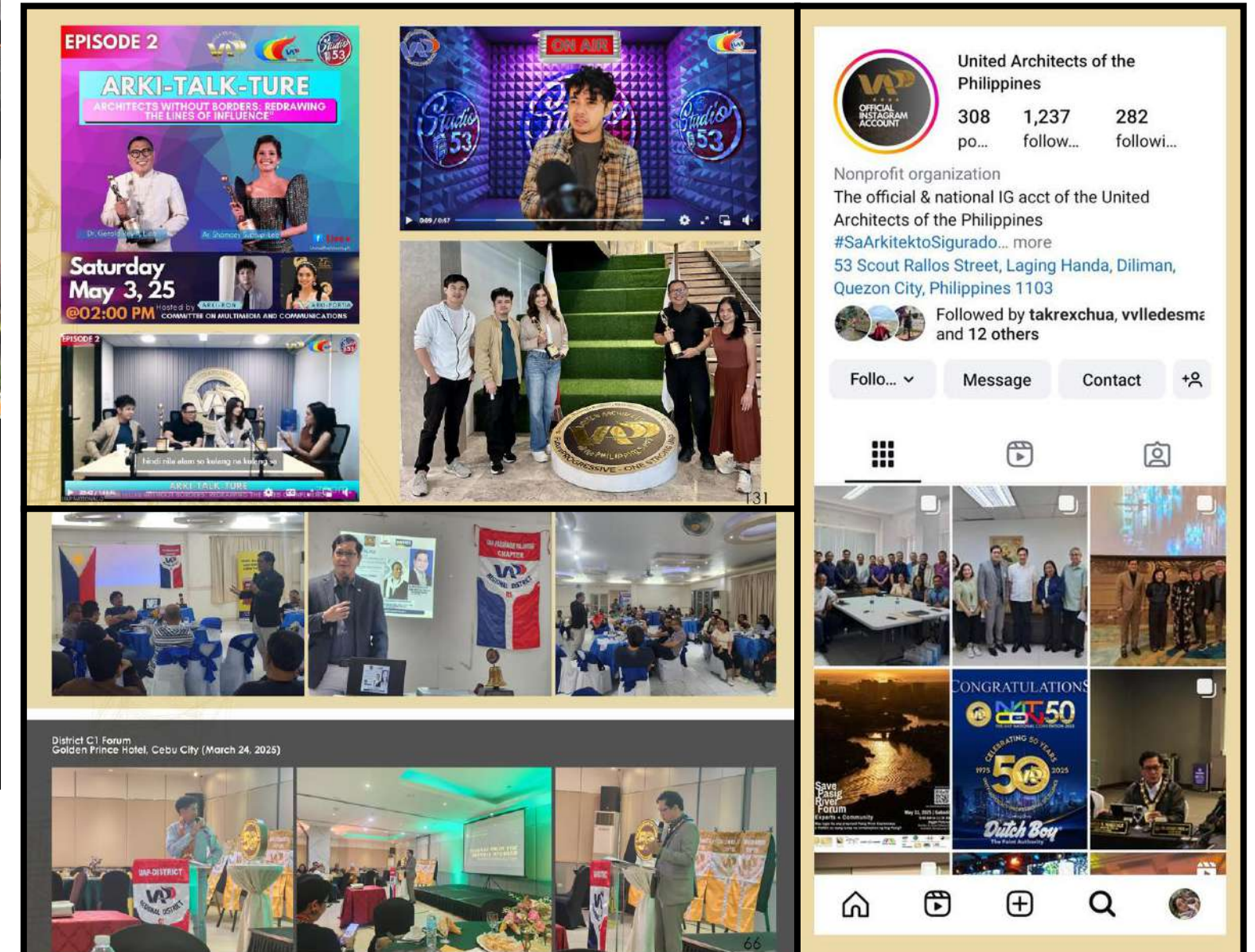

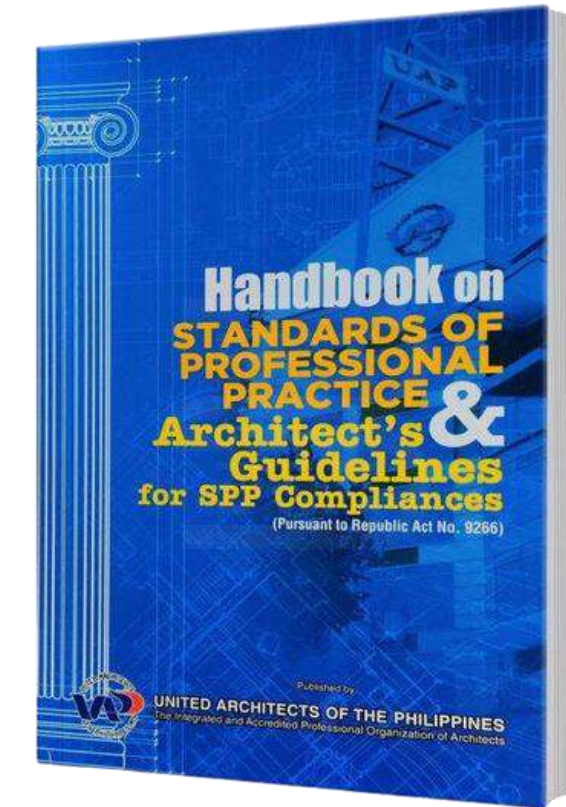
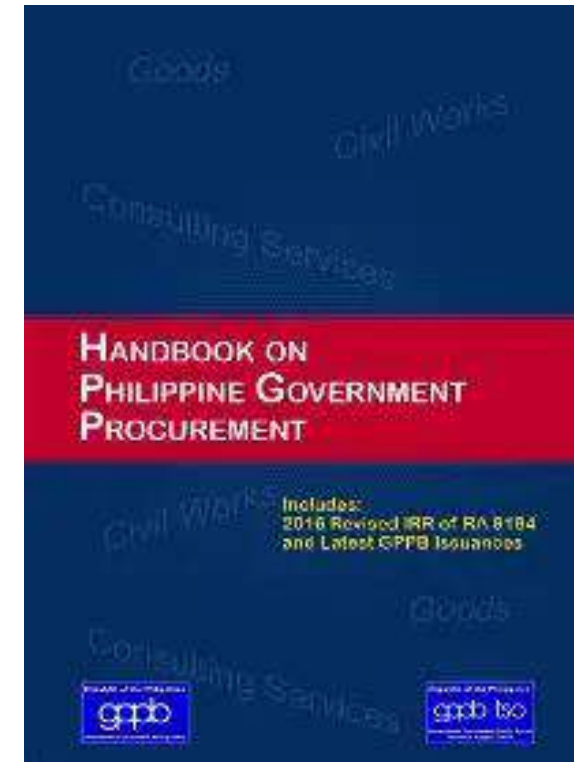
